## President's Message - Lorraine Robson

As I walk through the beautiful North Shore parks and forests on these gorgeous sunny fall days, I am reminded of a quote by Albert Camus: "Autumn is a second spring where every leaf is a flower." The brilliance of the red, orange, and gold leaves against the dark green conifers is spectacular this year, but reminds me that we are winding down the year. In my garden, too, the plants signal the coming end of the growing season. The last of the pink and white Japanese Anemones sway on their long stems, the clusters of intense purple berries of *Callicarpa bodinieri* 'Profusion' glisten in the sunlight, and a late-blooming Dahlia 'Liquid Desire' almost glows from within. Some wretched creature ate that Dahlia down to the ground earlier this summer, so I'm delighted to see it bloom at last. That's resilience!

As we approach our AGM in November, your LVGC Executive has been busy preparing and discussing the many details of the proposed budget for 2024, revising the language of the Constitution and By-laws to make that document gender-neutral and inclusive of everyone as well as updating a few points to reflect our club's current practices, and considering where best to recommend we donate our \$4,300 this year. You will find documentation supporting our recommendations in each of these three areas in this issue of *The Leaf*. Please read the documentation, ask any questions you may have, and consider how you will vote at the AGM.

With Thanksgiving only just recently past, I am still feeling thankful for my Executive team and the Committees who do so much for the club. Thank you to Judith Brook and Ann McKinnon for taking on extra duties and forming the Donation Committee with me this year to review suggestions and reach consensus on our recommendations. Thank you to our Treasurer, Jennifer Sydenham, for her careful consultation with each "department" in gathering figures for our proposed budget and for tracking the funds flowing in and out of our account all year. All the money talk lately makes me think of Sir Francis Bacon (who must have been a gardener as well as a philosopher, statesman, and scientist) who said: "Money is like manure, of very little use except it be spread."

Thank you to Sarah Gray, our Secretary, for her thorough minutes which document our discussions at the monthly Executive meetings and again at the General meetings. Thank



you to Maria Issa, our Newsletter Editor who, with her sidekick Margaret Campbell, miraculously sprouts a "Leaf" each month and sends out special notices of plants available to buy and other important news. Thank you to Aline Burlone, our Webmaster, who updates our website regularly so that it is both informative and beautiful and helps keep our Zoom participants connected. ## **DEBORAH JONES**

## **Rain Gardens**

Deborah Jones has a BA in Urban Studies, a Master's of Library Science, and worked for the Vancouver Public Library for over 30 years.

She and husband Ib Nielsen joined the volunteer group <u>Cougar Creek Streamkeepers</u> in 2004, after noticing illegal tree-cutting on the banks of the most productive salmon stream in North Delta. They put their gardening experience to work on a restoration planting project along that streambank – which gave them a ringside seat to the ravages of stormwater runoff flowing directly into the creek from nearby shopping malls, parking lots, streets and residential roofs.

A request to City of Delta for a pilot rain garden project gradually morphed into *many* projects. Deb now serves as volunteer Rain Gardens Coordinator for the Streamkeepers, overseeing the maintenance of 30 school and community rain gardens created since 2006 in collaboration with City of Delta, Delta School District, Pacific Salmon Foundation, Nature Trust of BC and others. She also advises the Nature Trust and Be the Change Earth Alliance on their rain garden grant programs.

# My new doormat has finally arrived!



## **BRIGHT SPOTS**

[As nobody sent me anything – you are stuck with whatever strange things are growing in my garden.]



While the annual march of the mushrooms has begun, there are other fun things that have just







woken up out of their drought-daze and decided to live wildly before the winter. The Beautyberry / Callicarpa is berrying like crazy. While not as magnificent as Maggie D's... I'm still pretty happy, especially as the leaves have nice, purple veins as well. The beautiful,

deep blue Monkshood that I got from Jennifer S. - is flowering now in several spots. I know it's poisonous - some recent Britbox murder mysteries have featured Aconitum - but it is a beautiful flower. In case you have someone on your hit list: as little as 2 mg of aconite or 1 g of the plant may cause death from respiratory paralysis or heart failure. Aconitine is a potent neurotoxin and cardiotoxin that causes persistent depolarization of neuronal sodium channels in tetrodotoxin-sensitive tissues. The influx of sodium through these channels and the delay in their repolarization increases their excitability and may lead to diarrhea, convulsions, ventricular arrhythmia and death: a dangerous beauty... On the other hand, a "rose by any other name..." but I don't know the rose's name as it a was an unwanted rescue with big, nasty thorns. I remember Hiromi having dug it out of a 'rescue garden" - but then refusing to take it home. It was left over after the plant sale 2 years ago – as it looked like hell - scraggly and nasty. We pruned each other – it was also a dangerous beauty! – as I bled from many places. Then I planted it. It forgave me – and has been blooming in great profusion since May! Surprisingly the chrysanthemum was also a rescue. I wasn't sure what it was, stuck it in a



plant had a bad year this year as its home and planter got

flowerpot and forgot about it: it tuned out OK. The BIG Sedum/Hylotelephium also decided to put on a great show... it has insinuated itself into many places in the garden

- because I know I didn't plant it! - but I'm glad it chose the spots it did.

The *Hydrangea* is completely bizarre. It started out achingly blue and now it's pink. Go figure. Physiostegia/Obedient







smushed by a falling wall. So, the entire tribe

had to be extracted from under the rubble, stashed in pots and dragged through the drought. In spite of the rotten care it has been receiving, it flowered. Maybe next year, there will be more. Finally, my

magical Japanese toad lily, Tricyrtis hirta, is starting to bloom. It was also a Plant Sale find - I don't know who donated it about 2 years ago - but I bless her gardening gloves! I love this little plant - and it has created offspring.



## Guttation - Lorraine Robson

For a gardening word nerd, what's better than learning a new word? Learning a new word about plants! I have observed guttation in one of my houseplants (when it annoyingly dripped moisture from its leaves onto the antique wooden coffee table), but I hadn't realized the process was different from transpiration. [For the Francophones among us, this cometh as no surprise – as 'goutte' is 'droplet'.] Guttation is the process of secretion of water droplets from the pores of some vascular plants like grass. Guttation is often confused with dew droplets that condense from the atmosphere onto the plant's surface. Check out the link in the October Links file.

## Philodendron Looking for a New Home - Whitney McMillan


There is a sexy philodendron that needs a sunny - but not too sunny! spot. Whitney writes: "It is a split leaf philodendron. I bought it coincidentally just before the initial Covid-era lockdown in 2020 - it was a smallish table-top size. Over the past few years it has grown, thriving in progressively larger pots and in several different locations. Only now I no longer have an indirect light location for its larger size. It is a gorgeous plant that simply needs a loving home. I am happy for a LVGC member to welcome it... and for LVGC to gain a donation for it. I am even happy to deliver it to its new forever home, if that's helpful."

Now, in case you don't know - Philodendrons are HOT!! They have a steamy sex life too. Not only do they generate heat (by metabolizing lipids) to attract pollinators, Philodendrons als act as a "Plant Pickup Joint".

In French Guiana, South America, you will find the Philodendron solimoesense - a flower that acts as the insect equivalent of a nightclub. The lily-like flowers, complete with a suggestively fleshly white stalk and 'copulation' chamber, produce heat, heady perfume, ample food, and a dark, quiet place to sleep it all off.

This is the perfect place for the scarab beetles to meet and mate - and perfect for the Philodendron, too. The bugs pick up its pollen during their nocturnal adventures and then spread it to other flowers, thus promoting the Philodendron's own sexual success.




The Floral Design Show Schedule and Exhibitor Registration form for the BC Council of Garden Clubs Fall General Meeting.

## PROPOSED MOTIONS

- 1. To approve the Proposed Budget for 2024 (see details in this *Leaf*).
- 2. To approve the Proposed LVGC Donations for 2023 (see details in this *Leaf*).
- 3. To approve the proposed revisions to make the language of the LVGC Constitution and By-laws gender-neutral, inclusive, and consistent.
- 4. To approve the proposed increase in the number of members of the club who can request a special general meeting from ten to twenty-five to reflect our increased membership numbers (Constitution Part 3.3).
- 5. To approve the proposed increase in the number of in-person and virtual members required to form a quorum at a special general meeting from fifteen to thirty-five (which is 20% of 175 members) (Constitution Part 3.4) and at a general meeting (Part 4.1).
- 6. To approve the increase of the Membership role from one chair to two cochairs and to increase the number of MALs from four to five to reflect our practice of the past few years (Constitution Part 5.1).
- 7. To approve the decrease from two years to one year for the length of time before a retiring executive can serve again following the completion of their maximum term (Constitution Part 5. 3).
- 8. To approve making the Constitution and by-laws available to each member on our website rather than by printing and distributing hard copies (Constitution Part 12.1).
- 9. To approve a change in the recipient of the club's money from the Scholarship Fund of the BC Council of Garden Clubs to the Vancouver Chapter of the Master Gardener Association if LVGC were to fold (Constitution Part 13.1).
- 10. To approve the explicit addition of members "attending virtually" to those who can vote on amendments to match the club's practice since we began meeting on Zoom three years ago (Constitution Part 14.1).

As will be discussed at the AGM, while a net loss was budgeted for 2023, we anticipate finishing the year with a modest profit. Our bank balance at the end of 2023 is projected to be approximately \$15,000. The Discretionary Expense line item was introduced at the September meeting and will be further reviewed at the AGM.

## Proposed Revisions of the LVGC Constitution and By-Laws

When I was a little girl in elementary school, I remember being puzzled and offended that all of our textbooks used "he", "him", and "his" as if everyone was male. How could our school books leave out at least half of all the students? That style was accepted for decades, but it's easy to re-write documents to make them gender-neutral and inclusive of everyone, no matter which pronouns you prefer to describe yourself. That's where the Executive started with our review

of the club's Constitution and By-laws although the review prompted us to propose a few more changes to simplify the language and to update this document to reflect our club's current practices. Please review the proposed changes and decide if you will vote for them at the AGM. Let Lorraine know if you have any questions.

## Key

- 1. Words crossed out like this or this will be deleted.
- 2. Changes in red make the text more gender-neutral or consistent (such as using "club" consistently rather than "society").
- 3. Changes in green are more substantive changes to the content (such as increasing the number of members required for a quorum to align with our increased membership numbers, increasing the number of Membership chairs or MALs to align with our practice, explicitly including Zoom participants in voting, and re-considering where our club's money would be directed should LVGC ever fold). (That day may come sooner than we expect if no one volunteers to serve on next year's Executive!)
- 4. Any rationale or explanation [in square brackets like this] will be omitted from the finished document.

## Lynn Valley Garden Club Constitution & By-Laws

#### **NAME**

The name of the organization is THE LYNN VALLEY GARDEN CLUB.

#### MISSION STATEMENT

To impart knowledge and stimulate a love of gardening among members and within our community.

#### **BY-LAWS**

#### PART 1 - INTERPRETATION

- 1. The word *Club* will be used in these by-laws interchangeably with the word *Organization*. [But "organization" is never used in this document except in the first line about the club's name and here, so it's not necessary. We propose simply referring to "the club" throughout this document.]
- 2. Words imparting the singular include the plural and vice-versa, and words imparting a male person include female and LGBT persons. [If this document is re-written in gender-neutral language to include everyone, this bit will not be needed.]
- 3. A resolution is one that requires a specific notice to members and said notice must be given not less than SEVEN days before the meeting at which it is to be voted upon.

## PART 2 - MEMBERSHIP

- 1. The club shall not exceed a membership of 175. An annual waiting list shall be maintained.
- 2. A person becomes a member of the society club upon payment of the annual dues of the society club. [We propose changing the term here and throughout this document from "society" to "club" since LVGC is not a registered society and we never refer to LVGC as a "society".]
- 3. Every member shall uphold the constitution and comply with these by-laws.
- 4. a) The annual membership dues shall be determined by the executive at its meeting prior to the November general meeting. Any change shall be presented to the membership at the above meeting, and upon approval, become effective January 1st of the following year.
- b) Dues are to be renewed at the January meeting for the current year.
- 5. a) Only members in good standing (i.e., his whose dues are paid and who does not have any debt owing by him to the Club) shall be entitled to vote or to take part in constitutional discussions at a meeting.
- b) Members in good standing for the previous six months shall be eligible for office.

#### PART 3 - MEETING OF MEMBERS

- 1. General meetings of the Club shall be held at the place, date, and time that the executive decides.
- 2. The Annual General Meeting shall be held in NOVEMBER.

- 3. The president shall call a special general meeting when requested by the executive or any ten (10) twenty-five (25) members of the Club. [We propose increasing this number to reflect the increase in our membership.]
- 4. No business shall be transacted at a special general meeting except that for which the meeting was called and shall require a quorum of fifteen (15) thirty-five (35) members including both in-person and virtual members. [We propose raising this number at the AGM in Nov 2023 to a quorum of 35 which is 20% of 175 members.]

## PART 4 - PROCEEDINGS AT GENERAL MEETINGS

- 1. A quorum of fifteen (15) thirty-five (35) members present both in person and virtually shall be required to carry on the business part of the meeting.
- 2. a) In the absence of the president, the vice-president shall preside. In the absence of both, any one of the executive may act as chair<del>man</del>.
  - b) The order of business shall be as follows:
    - Reading, correcting and adopting the minutes.
    - Business arising out of the minutes.
    - Reading and considering the correspondence.
    - Reading and considering reports from the executive and committees.
    - New business.
    - Special resolutions and amendments to the constitution and by-laws.
- 3. a) Only a member in good standing is entitled to vote on any motion.
  - Voting shall be by show of hands.
  - Voting by proxy shall not be permitted.
  - Motions shall be decided by a majority of votes.
- 4. a) The chair may propose a motion. However, to do so, he the chair must surrender the chair role to the vice chairman vice-president or someone else until his that motion has been disposed of.
  - b) In the case of an equality of vote, the deciding vote is cast by the chair has not previously voted. However, he the chair does not have to vote if he the chair does not wish to.
  - c) If the chair<del>man</del> has previously voted and there is an equality of votes, the proposed motion shall not pass.

## PART 5 – EXECUTIVE

- 1. The executive shall be a president, vice-president, secretary, treasurer, two membership chairperson co-chairs and four five members at large. [These two changes in number reflect our practice of the past few years, but we propose making it official by stating it here.]
- 2. The executive for the following year shall be elected at the general meeting in November. They shall assume their duties in January.
- 3. Terms of office are one calendar year, not to exceed two consecutive years in any one office and a maximum of four years of service on the executive. No retiring executive can assume any executive office for two years one year subsequent to completion of their maximum term. [Some feel, given how challenging it has been to find volunteers to serve on the executive, that we might want to allow them to serve again sooner.]

## PART 6 - PROCEDURE FOR ELECTION OF OFFICERS

- 1. a) The nominating committee shall be made up of two members of the general membership and one former executive officer. The nominating committee should be appointed in June with their duties to commence immediately.
  - b) A report from the nominating committee is presented to the general membership at the November meeting for the election of executive officers for the following year. Additional nominations may be made in writing or from the floor. In both instances, the nominator must have the prior consent of the nominee.

### PART 7 - PROCEEDINGS OF THE EXECUTIVE

- 1. A quorum of the executive shall consist of three members.
- 2. The executive may meet when and where they see fit but not less than eight times during the year.

- 3. In the absence of the president, the vice-president shall preside, or, in the absence of both, any one of the executive shall preside.
- 4. The executive shall be responsible for the planning of the general meetings and of any outside activities. The executive shall also have the management of the society's club's affairs.
- 5. The executive shall be empowered to form committees as they see fit; the committees, in turn, are answerable to the executive.
- 6. In the event that there is a vacancy on the executive during the term of office, the executive is empowered to appoint a member to take the place of the former member of the executive. He-The appointee shall hold office for the balance of the year.
- 7. The executive is empowered to remove from office an official acting against the interests of the society club.
- 8. All members of the executive are answerable to the executive as a whole and must conform to all decisions agreed upon.

### PART 8 - DUTIES OF THE EXECUTIVE

- 1. The president shall preside at general and executive meetings and shall preserve order. He The president shall be a member ex officio of all committees. On retirement he the president shall attend the first three executive meetings as past president ex officio.
- 2. The vice president shall perform the duties of the president in his the president's absence.
- 3. The secretary shall:
  - Keep minutes of all executive and general meetings
  - Conduct the correspondence
  - Have custody of all records and documents of the society club except those required to be kept by the treasurer.
- 4. In the absence of the secretary, the president shall call for a volunteer replacement.
- 5. The treasurer shall:
  - Collect all monies due the society club and deposit same in a chartered bank or credit union in Canada.
  - Keep accurate records of all transactions together with supporting invoices and receipts.
  - Furnish a statement thereof to the membership at each general meeting and to the executive upon request.
- 6. a) Signing officers shall be the president, vice-president and treasurer. Two of the three are required to sign all cheques.
  - b) Withdrawal of funds shall require two signatures.
  - c) Any disbursements over five hundred (\$500) must have the authority of the membership. Authority shall be based on a motion by a two-thirds majority vote.
- 7. The membership chairperson shall:
  - Collect fees from registrants and give to treasurer.
  - Keep accurate records of membership registrations and monies collected for same.
  - Furnish membership lists and reports as directed by the executive.
- 8. Members at Large shall assist other executive by carrying out projects and duties as assigned.

#### PART 9 - ANNUAL SOCIETY CLUB AUDIT

- 1. The executive shall appoint an auditor on or before November 30th.
- 2. No member of the executive shall be the auditor.
- 3. The auditor shall check the accounts of the <del>society</del> club together with the statement of income and expenses for the year as prepared by the treasurer.
- 4. Said audited report will be ready for presentation by the treasurer at the January general meeting.

## PART 10 - FISCAL YEAR

1. The fiscal year of the Club shall be from January 1st to December 31st.

#### PART 11 - ADDRESS OF THE CLUB

1. The address of the Club shall be determined by the executive from time to time.

## PART 12 - CONSTITUTION AND BY-LAWS

1. On being admitted to membership, each member is entitled to a copy of the constitution and by-laws of the society club, which the society shall give to him without charge will be posted on the club's website.

## PART 13 - EQUIPMENT DISPOSITION

1. On dissolution of the Lynn Valley Garden Club, the equipment owned by the Club should be sold and all monies received by such a sale, and any monies remaining in the bank account after payment of bills, should be donated to the Scholarship Fund of the BC Council of Garden Clubs Vancouver Chapter of the Master Gardener Association of BC.

[Rationale: the mission of the Master Gardeners to share knowledge and stimulate a love of gardening among members and within the community is very closely aligned with our club's mission. Several of our club members are also members of the Master Gardeners. The BCCGC Scholarship Fund currently has \$315,000 in it, but only about 4% is spent annually on scholarships (between \$10,000 to \$13,000 over the past few years). Although Master Gardeners are unpaid volunteers, they pay several hundred dollars for their own training in both the Basic and Advanced Training Programs.]

## PART 14 - AMENDMENTS

1. An amendment to this constitution and by-laws shall first be submitted to the society club at a general meeting in writing and then laid upon the table to be voted upon at the next general meeting. If two-thirds of the members then present and attending virtually vote in favour of the amendments, it shall be adopted.

## Lynn Valley Garden Club Donations Committee Report to the Members: October 2023

The Donation Committee, consisting of Judith Brook, Ann McKinnon, and Lorraine Robson, met to recommend where the club's \$4,300 should be donated. The \$4,000 is 50% of this year's Plant Sale profits while the \$300 is 100% of the money from selling Big Dig plants. Having reached consensus on our recommendations, and having received approval from the Executive, we are pleased to present them to the members to be voted on at the AGM in November.

When asked for input about our donations this year, we received six suggestions from one member and one more from a member which came in a few days after we had met. We have included some recipients from past years as well as including two of the new suggestions.

We considered the following criteria when recommending recipients: they had to be non-profit; impart knowledge of gardening; impart love of gardening; help in our community; and help people learn the value of growing food/planting for pollinators. Below is what we found with website addresses and brief descriptions.

- > Greater Vancouver Science Fair Two or three awards will be given to the winners of the Science Fair for botanically-related projects at the junior and senior high school levels. The organizers of the Science Fair will determine the winners.
- > City of North Vancouver Public Library for horticulture and sustainable living books
- > DNV Public Library for horticulture and sustainable living books
- Edible Garden Education Project <a href="http://ediblegardenproject.com/fed-up/">http://ediblegardenproject.com/fed-up/</a> The schools/parents have to provide the planters and have to have a minimum of 3 classrooms that will participate. It costs \$500 per class. Students from kindergarten to Gr. 12 participate in learning how to grow and harvest fresh, healthy produce and become active participants in our local sustainable food system.
- > Hospice (Lions Gate Hospital) We have several members whose families have used this place. Some of the Master Gardeners volunteer their time here so the garden creates a welcoming and soothing spot for patients and families. Wild Bird Trust administrating for Maplewood Conservation Area Two of their employees gave tours to about 50 of our members on our combined Field Trip and Members' Garden Tour in July 2022. They have a native plant garden in the area just past the nursery toward Osprey point, in addition to an outdoor classroom, viewing area, etc. They also have an existing Butterfly garden on site designed to attract the Anise Swallowtail butterfly.
- > YWCA Rooftop Garden <a href="https://ywcavan.org/blog/2021/09/ywca-rooftop-garden-help-keep-our-garden-flourishing">https://ywcavan.org/blog/2021/09/ywca-rooftop-garden-help-keep-our-garden-flourishing</a> In 2021, they grew 1600 pounds of food that helped feed the downtown eastside (in 2020 they provided 39,000 meals). The rooftop garden also attracts pollinators living in beehives on other rooftop gardens downtown.
- **BC** Council of Garden Clubs 80<sup>th</sup> Anniversary contribution to Scholarship Fund. They requested each club to give \$80.
- > SeedChange <a href="https://www.canasahelps.org/en/charities/SeedChange/">https://www.canasahelps.org/en/charities/SeedChange/</a> Operating since 1945 (formerly as USC Canada), they help farmers care for their families and communities by growing good food starting from good seeds. Matching funds of up to 5x may be available. They help build skills, diversify crops so farms are more resilient to climate change, increase vegetable production, and build community seed bank.
- Second Harvest <a href="https://www.canadahelps.org/en/charities/second-harvest/">https://www.canadahelps.org/en/charities/second-harvest/</a> This is the largest food-rescue organization in Canada working to grow an efficient food recovery network to fuel people and reduce environmental impacts of avoidable food waste.
